BOARDING AND GROOMING AGREEMENT AND RELEASE

1. I agree to pay for services and products requested by me for my pet such as daily boarding, exercise, grooming, medication, training and transportation at the rates established by Oakshadows Kennel Plus. I agree that this may include daily charges for unoccupied accommodations reserved by me.
2. Oakshadows Kennel Plus agrees to use appropriate safety precautions while boarding, grooming, training, transporting and/or otherwise caring for my pet.
3. I agree that Oakshadows Kennel Plus is not responsible for inadvertent and/or unforeseen side effects on my pet from boarding, grooming, training transporting and/or other care.
4. If Oakshadows Kennel Plus believes my pet needs additional care such as bathing or treatment for fleas during boarding and/or grooming, I agree that Oakshadows Kennel Plus may provide such care and at my expense. I am aware that there may be side effects to these treatments. I am also aware that any such treatment is not guaranteed 100% effective.
5. In the event Oakshadows Kennel Plus believes that my pet needs veterinary care, I authorize Oakshadows Kennel Plus to contact my pet's regular veterinarian to arrange for such care at my expense. If my pet's regular veterinarian is not available or Oakshadows Kennel Plus feels my pet needs immediate medical attention, I authorize Oakshadows Kennel Plus to contact another veterinarian and to arrange for said care at my expense.
6. I hereby release and discharge Oakshadows Kennel Plus from all claims, demands, damages, actions and causes of action whatsoever which can or may ever be asserted as a result of, related to or connected with (a) the presence of my pet at Oakshadows Kennel Plus; (b) the boarding, grooming, training, transportation and/or other care of my pet by Oakshadows Kennel Plus; (c) the presence of pets of other persons at Oakshadows Kennel Plus; and/or (d) the actions of pets of other persons during boarding, grooming, training, transportation or other care of said pets by Oakshadows Kennel Plus.
7. I agree that my failure to pick up my pet within seven (7) days of scheduled date constitutes abandonment of my pet. I further agree that in the event of such abandonment, Oakshadows Kennel Plus is authorized to exercise all rights of ownership of said pet.
8. I agree that this agreement covers the boarding, grooming, training, transporting and/or other care of my pet by Oakshadows Kennel Plus this date and hereafter.

I agree that by signing this agreement, I am acknowledging I have read this agreement, understand its terms and have signed it freely.
